## Skilled Capital 2018-19



Funded training is available in 2018-19 for the Skilled Capital ACT program. Skilled Capital is an ACT Government training initiative funded by the ACT and Australian Governments. Places are very limited, therefore early enrolment is recommended.

### STUDENT FEE CATEGORIES

#### Tuition Fee

Students are required to pay a tuition fee to contribute to the cost of training.

#### Fee Concession

Available for eligible students who at the commencement of training:

- hold a current Health Care Card or Pension Card, or
- can prove genuine hardship

Rule applies for students under 18 years of age if parent/guardian holds one of the above cards.

### Loadings

These may be applied to each student if they identify as:

- having a disability
- being of Aboriginal or Torres Strait Islander origin
- being youth at risk and/or
- long-term unemployed

Fee concessions and loadings will be applied through the enrolment process.

### Recognition of Prior Learning (RPL) and Credit Transfer (CT)

Where an eligible student is granted RPL or CT the qualification price will be adjusted, and a new student fee determined.

## ELIGIBLE PARTICIPANTS

- Must be an Australian citizen, a permanent Australian resident, or a New Zealand passport holder resident for more than six (6) months, **or**
- A person who holds a visa that is identified as being eligible, **and**
- Living or working in the ACT, **and**
- At least 15 years of age, **and**
- Not enrolled in or attending secondary school or college (some exceptions).

**Proof of eligibility** – students must make a declaration of their citizenship, residency or visa status. Australian citizens and permanent residents must provide evidence of one of the following to record the reference number: Australian Birth Certificate; Australian Passport; Australian Permanent Resident Visa; Nationalisation Certificate; Green Medicare Card. Eligible visa holders must provide evidence of their status.

## COMPLETION PAYMENT

Students who successfully complete their qualification are eligible for a completion payment. A completion payment will be paid directly to the student upon completion of the qualification and a survey. The completion payment is:

- \$300 for each qualification
